

Platte View Estates Architectural Guidelines

INTRODUCTION

The “Platte View Estates” area of Hamilton County consists of the area shown on map, attached hereto.

The purpose of this document is to:

1. Describe the design review application and approval procedures of the Platte View Estates Homeowner’s Association Committee of Architecture, and
2. Communicate those specific design and use elements that will create a very unique and desirable residential neighborhood character for Platte View Estates.

Prior to investing extensive time and money in the preparation of detailed plans, it is strongly advised that lot owners and their architect and/or engineer meet with a member of the committee of architecture and discuss preliminary concept plans.

These guidelines will be administered on a case-by case basis in order to encourage excellence in design. Architects and engineers should not use the Guidelines as constraints to creativity, but rather as parameters within which the Platte View Estates area as a whole is characterized and protected.

These guidelines may be amended by the Committee of Architecture from time to time.

SUBMITTAL REQUIREMENTS AND APPROVAL PROCEDURES

PLATTE VIEW ESTATES

Prior to obtaining a building permit from Hamilton County, the following items must be submitted to the committee for approval:

1. Application for Plan Review (attached).
2. A plot plan of your lot showing the placement of the building, driveways, sidewalks, retaining walls and the set-back distances from your lot line to these improvements. This plan should show the driveway elevations at street side.
3. Your proposed floor plan and elevations.
4. Information sheet (attached).
